It is understood that a "Rental Day" is ten (10) hours; Between 8:00AM and 6:00PM. Additional time will be charged at the rate of \$100.00 per hour. There is an additional fee of \$250 for weekend bookings.

Blue Sky Rental Studios, Inc. [BSRS] shall not be held liable for failure to provide services covered by the temporary use of BSRS due to any cause beyond BSRS's or its agent's control.

Cancellation Policy

In order to avoid cancellation fees, cancellation (or postponment) notices must be received no less than two (2) business days prior to the reservation date and time. Business days are based on a 5-day workweek, Monday through Friday, 8:00 AM until 6:00PM. Cancellations received less than two (2) business days prior to the reservation date and time will incur a fee equal to 50% of the quoted fees. 100% of the quoted fees will be due for any cancellations received less than one (1) business day prior to the reservation date and time.

For multiple day bookings, notice equal to the number of rental days is required. For example, a week long shoot will require a notice of five business days. Failure to comply will result in full payment due, unless the studio can be rebooked.

Rental Fee

A deposit equal to 50% of the rental fee is due upon confirming a studio. Full payment will be due upon occupying the studio. Any additional charges will be due upon the submission of the invoice at the end of the day. Client agrees to pay any cleaning fees deemed necessary beyond normal use (i.e. paint damage and carpet stains). Client agrees to pay all charges for damage to furnishings or equipment. Client agrees to pay all reasonable attorney's fees and costs which may be incurred in connection with the collection of any unpaid accounts.

Insurance

Certificate naming Blue Sky Rental Studios, Inc. must be sent or faxed prior to the start of production.

Client acknowledges that BSRS is not an insurer. The amounts payable to BSRS here under are based solely upon the value of services rendered under the Authorization and are unrelated to the value of the Client's property or the property of others located in or about BSRS or in the Client's possession.

Client acknowledges that BSRS does not have any specific knowledge of the property of the Client, personal or otherwise or of the equipment in the possession or of the value of any of the aforesaid or of any person or persons that are or may be in or about BSRS and it is not possible to ascertain the value of or amount of any damage that might be claimed relative to the services rendered under the Authorization.

Client therefore agrees that BSRS shall not be liable for any loss, damage or injury arising out of the services rendered by BSRS. Client further agrees to that extent to indemnify and defend BSRS.

This authorization represents the entire agreement between the parties and no other agreements, understandings or representations, whether written or oral have been made or relied upon by either party. No modifications or changes can be made unless BSRS agrees to such in writing.

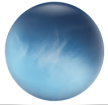
